The Fairmount Fire Protection District (FFPD) accepts applications year-round for new and lateral volunteer positions. These applications are processed as received for lateral firefighters, and twice a year for new firefighters.

A \$75 non-refundable application will be collected to process any volunteer applications submitted.

All applicants who are interested in becoming a volunteer member of the Fairmount Fire Protection District must be at least 18 years old and have a valid driver's license. The applicants must pass a background screen prior to continue in the hiring process. Once approved, the applicant will participate in the following process:

- I. Provide a valid nationally accredited IAFF CPAT certification/or a signed release to complete the FFPD Physical Ability Test.
- II. Pass a general aptitude of FF-I Written Test with a score of 70% or higher.
- III. Complete two 4 hour ride-a-longs with FFPD crews at each station. (May be completed consecutively)
- IV. Complete an Oral Board Interview.
- V. Complete a FFPD sponsored physical.
- VI. Sign a Conditional Offer for Firefighter Status letter.
- VII.Complete the FFPD Firefighter Academy.
